1. Eligibility criteria for appointment:

- (I) The Cost Accountant Firm must have minimum 5 years experience of Cost Audit of PSUs engaged in construction activities or public limited companies having more than Rs 500 crore turnover.
- (II) Cost Accountant Firm must be holding valid Certificate of practice issued by Institute of Cost Accountants of India.
- (III) Certify that the appointment is read with section 139,141 & 148 of the Companies Act, 2013.
- (IV) No conditional offer will be considered.

2. The detailed information about the Cost Accountant Firm is to be submitted in Part-I attached along with a declaration with the bid.

For the selection of Cost Accountant Firm for appointment on the basis of the above details, Management's discretion shall be final and shall have the right to reject or accept any prospective applicant without assigning any reason whatsoever.

- (II) All formats as required are to be certified for 2016-17.
- (III) To prepare the Cost Records of all Zones/Units.

5. Submission of Report:

Cost Accountant Firm will start conducting the job as per intimation by the Corporation and will submit the draft report to Manager (F) NPCC Ltd. within prescribed time as laid down in the Act from the close of the Financial Year.

6. Other Terms & Conditions:

The appointment of auditors is subject to the following declarations:

Cost Accountant Firm must not sub-contract the work;

Cost Accountant Firm will work in strict confidence and will ensure that the information in respect of the operation of the Area/Unit is dealt in strict confidence and secrecy. A Certificate towards maintaining confidentiality to be provided by the Cost Auditor before Commencement of audit.

No partner of the Cost Accountant Firm is in any way a related party as per section 2(76) or a relative within the meaning of section 2(77) of the Companies Act, 2013;

Neither the Cost Accountant Firm nor its partners or Associates have any interest in the business of Corporation;

The Cost Accountant Firm will be required to issue Certificate of Independence;

The Cost Accountant Firm shall have prime responsibility to ensure that it does not violate the limits on number of audit specified under the Companies Act, 2013.

The Cost Accountant Firm shall be free from any disqualification under the Companies Act 2013

The Cost Accountant Firm / partners holding certificate of practice issued by Institute of Cost Accountants of India are in whole time practice.

The Cost Accountant Firm shall undertake that data given to the Auditor by **NPCC** and any information generated from the data provided shall not be used by the Auditor for any other purpose.

The Cost Accountant Firm will be debarred from getting, in future, the Cost audit of NPCC if:

- I. The Firm obtains the appointment on the basis of false information/false statement.
- II. The Firm does not take up audit in terms of appointment letter.
- III. The Firm does not submit the audit report, complete in all respect in terms of Appointment.
- IV. The Firm violates any of the stipulations under clause as above.

The offer should be submitted strictly as per the terms & conditions laid down in the document. Jurisdiction of Courts: Any dispute arising out of or in respect of the contract will be subjected to the jurisdiction Faridabad, Haryana.

Disclaimer: NPCC reserves the right to accept or reject any or all tenders and to request additional submission or clarification from one or more Applicant(s) at any stage or to cancel the process entirely without assigning any reason.

Cost Accountants Firm shall be asked to be present at Board Meeting of the Company when the board so required.

EMD and Processing fee should be kept in a separate envelop and enclosed with Technical Bid.

Bidder has to enclose Demand draft of Rs.5000/-and of Rs.500/- in favour of National Projects

Construction Corporation Limited payable at Faridabad of Nationalized /scheduled bank in India as EMD and processing fee respectively with Technical bid.

Demand Draft for EMD & Processing fee should be separately.

The financial bid of only those tenders will be opened whose technical bids will be found in order.

In case date of opening the tender happens to be holiday, the tenders will be opened on the next working day at same time.

The fee may be quoted in lump-sum excluding of service tax which will be paid as applicable. However the bidder will be solely responsible for deposition of service tax to the respective Government Authority under his liability.

The payment will be made against bill / invoice after the completion of job/work / submission of Cost Audit Report and approval by Board.

The tenderers shall submit their personal profile along with tender/quotation on prescribed tender form attached therewith and <u>if found un-satisfactory</u>, the tender <u>documents so</u> received shall be rejected.

EMD and Processing fee shall not be accepted by cheque / cash. It should be in the form of Demand Draft, payable in favour of <u>National Projects Construction Corporation Limited</u>, payable at Faridabad (Haryana). Tender documents without submission of EMD & processing fee will be summarily rejected.

Processing fee will be Non-Refundable.

After Finalisation of Bids, EMD of unsuccessful bidder will be refunded.
