National Safai Karamcharis Finance & Development Corporation (NSKFDC), a Govt of India Undertaking under the Ministry of Social Justice & Empowerment was incorporated on 24<sup>th</sup> January, 1997, as a Company 'Not for Profit under the erstwhile section 25 of the Companies Act, 1956 (now Section 8 of the Companies Act, 2013).The Authorised Share Capital of the Corporation is Rs. 710 crore and paid up capital is Rs. 599.94 crores as on date.

The mission of NSKFDC is to endow alternate means of livelihood to Safai Karamcharis (including waste pickers), Scavengers and their dependents to enable them live with dignity, honour and pride along with the mainstream of the Society.

The objectives of NSKFDC are to promote socio-economic upliftment of Safai Karamcharis (including waste pickers), Scavengers and their dependents by way of providing financial assistance at concessional rates of interest for income generating activities and loans to students for pursuing professional and technical education through its State Channelizing Agencies (SCAs)/Regional Rural Banks(RRBs) and Nationalized Banks. The cumulative disbursement of the Corporation as on 31/03/2018 was Rs. 1575.43 Crores covering 349821 beneficiaries across the country.

NSKFDC has to hire the services of a Chartered Accountants Firm for conducting audit under the provisions of Section 35(5) of GST Act of the Corporation for the financial year 2017-18.

**2. TENURE:**


- The appointment of GST Auditor for conducting audit under GST Act for the financial year 2017-18 shall be for one year which may be extendable on the basis of the performance.
