SECTION-I DETAIL NOTICE INVITING BIDS FOR

North Eastern Electric Power Corporation Limited (NEEPCO Ltd.), a leading Miniratna Category-I Public Sector Enterprise under the Ministry of Power, Government of India, invites online Bids at e-procurement portal https://etenders.gov.in for Empanelment of cost Auditors for the Financial Year 2022-23, 2023-24 & 2024-25.

1. Scope of Services

Detailed scope of work shall be as under:

- 1.1 To Carry out Cost Audit of the Power Stations of Company zone-wise as detailed in Clause-2, Section-II- Information for Bidders, in accordance with the provisions of Section 148 of the Companies Act, 2013 and provisions of the Companies (Cost Records and Audit) Rules 2014 and amendments thereto. Cost Audit shall be in adherence to the relevant orders/clarification issued by Cost Audit Branch, Ministry of Corporate Affairs, Govt. of India and the Cost Accounting Standards issued by the Institute of Cost Accountants of India, from time to time.
- 1.2 The Lead Cost Auditor designated by the Company shall consolidate Cost Audit Reports and annexure to cost audit reports of all power stations as certified by the respective Cost Auditors of the Power Stations. The Lead Cost Auditor shall also work for conversion of Consolidated Cost Audit Reports in XBRL mode, filling the same with Central Government and other associated works at Corporate Office, located at Shillong or at the Company's Guwahati office.
- 1.3 Compliance with any other instruction issued in respect of cost audit under the Companies Act 2013.
- 1.4 Attending meetings (including Audit Committee and Board of Directors meeting) of the Company for matters relating to Cost Audit / Reports.

2. Bidding Procedure:

The Bidder shall submit online bids under Single-Stage Single-Envelope bidding system.

3. Duration of Appointment

3.1 Based on the evaluation of the bids, NEEPCO shall empanel 6 (six) Cost Audit firms. The qualified firm will be empanelled for a period of 03 (three) years from the FY 2022-23. However, appointment will be given to the eligible Cost Audit Firms on year to year basis as per the agreed terms & conditions, subject to the satisfactory performance and approval of the appropriate authority.

4. Qualifying Requirements

4.1 General Qualifying Requirements

- i) A bidder shall be a registered entity in India.

- iii) The individual or the firm, as the case may be, satisfies the criteria provided in section 141 of the Companies Act 2013, so far as may be applicable.
- iv) The proposed appointment is within the limits laid down by or under the authority of the Companies Act 2013.

5. Bids by Consortium / Joint-Venture Companies:

Formation of Consortium /Joint-Venture for participation in the tender is not allowed.

6. Participation in Bids

6.1 E-Tendering / E-Procurement:

This tender is being processed through e-tendering/e-procurement system. The bidding documents are to be downloaded from https://etenders.gov.in and bids are to be submitted/ uploaded through above e-tendering system. Guidelines for e- tendering system are available on e- tender portal.

6.2 Registration for Participation in Bids

- (a) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: https://etenders.gov.in/eprocure/app) by clicking on the link "Online bidder Enrollment" on the CPP Portal which is free of charge.
- (b) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- (c) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- (d) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- (e) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- (f) Bidder can then log in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.
