For participating in the work mentioned either at S.No. option 'A' or option 'B', the tenderer shall be pre-qualified on the basis of the following criteria:

1. For Option A

- The tenderer should have minimum turnover of **Rs.5.40 Lac** in any one of the immediate three preceding financial years 2014-15, 2015-16 and 2016-17 in its own name.
- The Tenderer should be CA/CMA firm with valid registration

2. For Option B

- The tenderer should have minimum turnover of **Rs.4.20 Lac** in any one of the immediate three preceding financial years 2014-15, 2015-16 and 2016-17 in its own name.
- The Tenderer should be CA/CMA firm with valid registration

For participating in both the works combined, as mentioned at S.No option 'A' and option 'B', the tenderer shall be pre-qualified on the basis of the following criteria:

- i. The tenderer should have minimum turnover of Rs. 9.60 lac in any one of the immediate three preceding financial years 2014-15, 2015-16 and 2016-17 in its own name.
- ii. The Tenderer should be CA/CMA firm with valid registration .

The uploaded bid document shall be considered valid for participation in the bid process subject to submission of required cost of tender document, e-Tendering processing fee & EMD and the same shall be reached to the office of undersigned on or before the time specified for opening of techno-commercial part of tender.

The tender shall be pre-qualified on the basis of documents uploaded along with Techno-commercial bid in support of above. The decision of the company will be final and binding in this regard. The financial bid of only those bidders shall be opened who qualify in technical bid as per the above criteria & only qualified bidders will be informed about price bid opening.
