Extension of date for invitation of proposals for Internal Audit FY 2024-25

1. The Rajasthan State Co-operative Bank Ltd. Jaipur, a scheduled bank in cooperative sector, having its 16 branches (12 branches at Jaipur and one each at Jodhpur, Udaipur, Bikaner and Kota) invites proposals from qualified professional Chartered Accountant firms to conduct Internal Audit of the bank H.O. and its branches for the **Financial Year 2024-25**.
2. The Internal Audit for the year will be completed on quarterly basis and the final & complete report will have to be submitted latest by next coming month positively.
3. The firms desirous of taking up the work order/project are required to submit their proposals in response to this notification with particular reference to the basic profile of the firm.
4. The applicant firm must fulfill the following basic Terms and Conditions -
 - It should be **CA firm/LLP of CA/Cost Accountant registered in India.**
 - It must have its **Head Office in Rajasthan only.**
 - In respect of branch internal audit, preference will be given to the firm registered in the district in which the branch is functioning.
 - It should have the **experience of Audits in banks.**
 - It should have **full-time qualified CAs/CMAs/members of LLP.**
 - It should not have been **barred /blacklisted /disqualified by any regulatory/statutory body** on the date of the submission of the application.
 - It should **not be a consultant or GST Auditor of our bank.**
5. The proposal applications must clearly indicate the minimum fee acceptable for the work order for each branch.

The proposal applications superscribing "PROPOSAL FOR APPOINTMENT OF INTERNAL AUDITOR 2024-25: NOTIFICATION REFERENCE NO." should be addressed to MANAGING DIRECTOR, The Rajasthan State Cooperative Bank Ltd, DC-1, Lal Kothi Shopping Center, Opposite Nehru Balodyan, Tonk Road, Jaipur-302015 and the sealed envelope containing the proposals should be submitted at the address mentioned not later than 04:00 PM of 25th June 2024.
