

1. BID SUBMISSION:

- b) EMD of the bidder shall be forfeited, if the bidder withdraws or amends its bids or impairs or derogates form the bid in any respect with in the period of validity of the bid. The EMD of the successful bidder shall be released after successfully completion of work. If the contractor is failed to fulfill his obligations, the EMD, retained shall be forfeited. Tender without EMD will be out-rightly rejected.
- c) Micro or Small Enterprises (MSE)/NSIC registered firms are exempted from submission of the "EMD" and must Upload the scanned copy of the MSE/NSIC certificate. 
Remarks: - The EMD in the form of DD/BG, outstation / local Cheque, outstation DDs / by hand written DDs is not acceptable.

- 5. SJVN Ltd. has to finalize its tender within a limited time schedule. Therefore it may not be feasible in this case for SJVN Ltd. to seek clarifications in respect of incomplete offers. The decision will be made based on available documents. Prospective bidders are advised to ensure that their bids are complete in all respects and confirm to our terms and conditions. Bids not complying with SJVN Ltd. requirements may be rejected without seeking any clarifications.
- 6. Notwithstanding anything stated above, the SJVN Ltd. reserves the right to assess bidder's capability and capacity to perform the works, should the circumstances warrant such an assessment in the overall interest of the SJVN Ltd.
- 7. The scope of work is given in the Bill of Quantities of the Bidding Documents. The Bidder shall be required to offer their rates and prices for the whole work, which shall include manpower, stationary, tools, accommodation, to & fro travelling expenses upto Project Site, taxes & duties etc. except **GST**.

- No Mobile Phone will be permitted inside the bid opening room. Therefore, bidders should deposit Mobile Phones with Security gate at Reception.
- The work will be awarded to lowest (L-1) bidder. Bids shall be evaluated on overall basis for total financial implication including taxes. However; in case of unregistered dealer under GST Act, if GST is payable/ becomes payable on such services under reverse charge basis (RCM) upto the date of opening of bids, then the bids of such bidders shall be evaluated by loading applicable GST under RCM for purpose of determining lowest (L-1) bidder.
- Time Period & L. D. :-The entire work shall be completed within 30 days from the issue of LOA including submission of the final report. The scanned copy of LOA will be emailed/ faxed to the successful bidder. However, in case the report is delayed beyond the stipulated time period of 30 days; then liquidity damage charges @ $\frac{1}{2}$ % per week or part thereof subject to maximum of 5% of the award value shall be levied. LD Charges with GST at applicable rate (presently rate is 18%) shall be recovered from the contractor in case L.D. charges are leviable as per the terms of the contract.
- Time is the essence of the contract and no hindrance shall be considerable unless intimated by the contractor within 24 hrs. from its occurrence.
