A. PREAMBLE

West Bengal State Electricity Distribution Company Limited (WBSEDCL), a Govt. of West Bengal Enterprise has come in to effect from 01.04.2007 after restructuring of West Bengal State Electricity Board in compliance with Electricity Act 2003. WBSEDCL is the major power distribution utility in the state of West Bengal.

WBSEDCL has a joint venture named New Town Electric Supply Company Ltd with equity participation of 50%. The Company has an associate named West Bengal Green Energy Development Corporation Limited with an equity participation of 35%. WBSEDCL's stake in premier power Exchange named Power Exchange India Limited is equivalent to 5%. The Company provides power to 96% requirement in the state of West Bengal, catering to every sector, from villages to huge industrial units. It serves a customer base of more than one and half crore across the State. The service network spans over 5 Zones, 19 Regional Offices, 72 Distribution Divisions and 508 Customer Care Centres.

WBSEDCL generates some amount of Hydro power& Pump storage power and draws power from State and Central power Utilities to meet up the consumer's demand.
