The Ministry of Corporate Affairs has constituted the National Company Law Tribunal (NCLT) vide notification no. S.O. 1932(E) dated 01.06.2016 and National Company Law Appellate Tribunal (NCLAT) vide notification no. S.O. 1933(E) dated 01.06.2016 with effect from 1st June, 2016. Further, the MCA vide notification no. S.O. 1934(E) dated 01.06.2016 has notified the sections relating to the Companies Act, 2013 effective from June 01, 2016.

The MCA vide notification no S.O.1936(E) dated 01.06.2016 has appoint the date 01.06.2016 on which all matter or proceedings or cases pending before the Company Law Board will be transferred to National Company Law Tribunal. The NCLT rules will be notified by the Ministry of Corporate Affairs in due course.

As a part of the capacity building initiatives for members, the Institute of Cost Accountants of India is conducting a series of weekly workshops on NCLT and NCLAT along with other provisions of the Companies Act, 2013 including Case Laws Digest.

CMA Dr. M.S. Vasan, Managing Partner – MSV Legal Attorneys, would be addressing the workshop and will provide broad vistas of the scenario bringing his expertise in handling company law matters.
